

## **CORYDON TOWNSHIP SUPERVISORS**

### **REGULAR MEETING**

**July 14, 2025**

#### **CALL TO ORDER**

The July 14, 2025 regular meeting of the Corydon Township Supervisors was called to order at 6:00 pm by Dennis Faucher, Chairman. The Pledge of Allegiance Followed.

#### **PRESENT**

#### **APPROVAL OF MINUTES**

#### **NEW BUSINESS**

- Allegheny National Forest Receipts Distribution – Documentation was presented. Corydon Township received a \$101,573.31 allotment, which is \$18,882.70 more than last year. The Allegheny Forest Alliance sent a request for 1% of this allocation. Dennis Faucher made a motion to decline this request. Michael Yohe seconded. All were in favor.

- Change of Assessment Notices – These changes were presented to the Supervisors for review.
- 2025 Municipal Liquid Fuels Allocation – This application for Salt and Sand in the amount of \$1139.72 was presented to the Supervisors to approve and sign the application. It will be submitted to the County for approval.
- Yohe Road Garage Condition – The property owner has been contacted and a request made for his attention to this matter.
